2016 LCCA HOME GARDEN & LEISURE SHOW TERMS AND CONDITIONS

1. Exhibit Hours - The LCCA shall determine and publicize the exhibit hours the show will be open to the public.

2. Merchandise Removal - No Exhibit or merchandise may be removed from the building until 4:00 pm of the closing day without a Removal Order signed by the LCCA.

3. Liability - The Exhibitor is entirely responsible for the space occupied by him and shall not injure, mar or deface the premises. The Exhibitor shall not drive nor permit to be driven, any pins, nails, hooks, tacks, or screws in any part of the building. Furthermore, the Exhibitor shall not affix or use adhesive type of material on painted surfaces. Automobiles, trucks and similar conveyances shall have drip pan and/or protective material under them to safeguard the floor from oil stains, etc., and all landscaped areas must have a similar barrier under to safeguard the floor. The Exhibitor agrees to reimburse the LCCA and/or the Cowlitz County Expo Center for any loss or damage occurring to the premises or equipment.

4. Aisles - All exhibits and personnel must remain within the confines of their own spaces and no Exhibitor will be permitted to erect signs or display products obstructing the view or disadvantageously affect the display of other exhibitors.

5. Space - The contracted space is to be used soley by the Exhibitor whose name appears on the Contract and no portion can be sublet or assigned. The Exhibitor shall forfeit his right to the space, all prepaid space costs and upon demand pay any balance owing to LCCA if he fails to occupy or use his space or to have his exhibit completed and in place by 9:00 pm the day before the opening day of the show unless previous arrangements have been made with the LCCA. If Exhibitor forfeits the space, LCCA may re-let the space without liability to the Exhibitor.

6. Reassignment - LCCA shall have the right and privilege of moving an Exhibitor to another location in order to conform to all County, State and Federal laws and regulations and the general display requirements and guidelines of LCCA.

7. Participants - This agreement does not reserve for, nor guarantee to, the exhibitor any space, a specific area or space priority, right of first refusal or any other manner of participation in any future show.

8. Electricity - All electrical connections shall be equipped with an Equipment Ground Conductor. For any additional electrical requirements contact the LCCA.

9. Cancellation of Contract - If this agreement is cancelled by Exhibitor for any reason, or by LCCA because of Exhibitor's default or violation of this agreement, monies paid to LCCA by Exhibitor shall be retained at LCCA's discression. ANY CANCELLATION MUST BE IN WRITING. 10. Liability of Management - If the show is cancelled, delayed, interrupted or not held as scheduled for any reason, other than an act of God, Exhibitor's damages shall be limited to only the cost of the reserved space paid to the LCCA and the LCCA shall not be liable for any other damages or expenses; the LCCA shall not be liable for any refund, damages or expenses if caused by an act of God. In the event of any breach of contract other than cancellation, delay interruption or not holding the show as scheduled, Exhibitor's damages shall be limited to the cost for the reserved space paid to the LCCA.

11. Indemnification - Exhibitor shall protect, defend, indemnify and hold harmless the LCCA, the LCCA and Cowlitz County Expo Center, their officers, agents and employees from and against any and all claims, damages, losses and expenses including attorney's fees arising out of or resulting from the exhibit and the activities of the Exhibitor and the officers, contractors, licensees agents, employees, guests, invitees or visitors of exhibitor, including but not limited to claims, damages, losses and expenses arising out of or resulting from performance of live or recorded music or other copyrighted works with the exhibit and arising out of or resulting from disputes between exhibitors regarding violations of unfair trade practice laws or patent of copyright laws.

12. Insurance - Exhibitor shall secure and maintain liability insurance, naming the LCCA, and the Cowlitz County Expo Center, their officers, agents and employees as additional insured, to protect them from claims which may arise out of or result from the activities of the Exhibitor. A Certificate of Insurance is to be furnished to the LCCA. Neither the LCCA nor the Cowlitz County Expo Center shall be responsible for loss or damage occurring to the exhibit or sustained by the Exhibitor from any cause. Such additional insurance, if desired, must be obtained by the Exhibitor.

13. Attorney's Fees - If a civil action arises between the parties out of this agreement or to enforce any of its provisions, the losing party shall pay the attorney's fees of the prevailing party as trial court may adjudge reasonable and if an appeal is taken from any judgment of the trial court, the losing party shall pay the amount the Appellate Court shall adjudge reasonable as the prevailing party's attorney's fees on appeal.

14. Consent - Exhibitor hereby consents to the LCCA's royalty-free use of visual and audio reproduction of Exhibitor and its employees and exhibit(s) including without limitation recordings, photographs, video tapes, films and other images or likenesses for the purpose of advertisement and promotion of this and future shows. Exhibitor also agrees to allow the LCCA to send faxes and e-mails pertaining to the show.
